Student award winners welcomed at YouTube Burn

Masconomet receives first prize second year in a row

Shriners Hospitals for Children — Boston hosted the 11th annual statewide You-TubeTM Burn Awareness Video Contest awards ceremony on Tuesday, March 12. Staff members, contestants, sponsors and prominent fire educators gathered in the auditorium to screen the top three videos along with three honorable mentions. The contest is open to all Massachusetts schools with sponsored communications courses or extracurricular groups, with review and approval required by teacher or faculty sponsors. Submissions raised awareness about fire and burn safety with one-to-three-minute videos while being educational, informative and entertaining. "The use of social media, specifically YouTube, has tremendous power and influence today. These students are influencers, and these videos are a way for them to learn something and teach something," said State Fire Marshal Peter J. Ostroskey. Marshal Ostroskey also spoke about the negative impacts resulting from the ease of uploading a video to YouTube how dangerous challenges spread rapidly. "This underscores the continued need for this contest as a way to teach young people about fire safety and risk taking."

"The goal of the contest is to counteract the inaccurate and dangerous information of so many YouTube videos by allowing teens to explore what they really need to know about fires and burns, using the media of today – video – without getting hurt," added Captain Rick Tustin, president of MaSAFE, a sponsor of the event. The first place team was awarded a new DSLR camera and \$200 in gift cards, the second place team shared \$100 in gift cards and the third place team shared \$50 in gift cards.

Masconomet Regional High School took first place this year with their video Burn Awareness, which focused on kitchen safety and burn prevention over a meal. Runner up Fire Safety is SIMple, from Northbridge High School, used the popular video game Sims to create an out-of-

screen learning experience. Melrose High School secured third place with Prevention Detectors, a creative idea that uses smoke detectors as humorous vocal alerts. Three teams from Braintree, Millis and Nauset Regional High Schools received honorable mention for their entries.

The idea of teens educating teens was a prominent theme throughout the event, as speakers noted the importance of young adults rallying together to create change. A total of 58 teams from 15 Massachusetts schools submitted projects.
